# <u>Message from Richard Dawson - Head of UK & Europe</u> and Patron of the ANZ Pensioners' Association UK



It's my pleasure to address you for the first time as ANZ's Head of UK & Europe. I hope that you and your loved ones are safe & well in these extraordinary and unprecedented times.

I have very much enjoyed my first six months in the UK, and was delighted to have been appointed permanently to the role at the beginning of April. I have been impressed with the energy and drive of the ANZ Europe team, and particularly humbled how fantastically everyone has pulled together over the last three months. Despite working in a very challenging environment, the team is continuing to deliver for our customers, each other and our shareholders.

I am sure you are interested to know how we are operating during this crisis. First and foremost, the health and safety of our team members, their families and the general community is our priority, and we made the decision before the crisis took hold to encourage everyone to work from home if they could. As the crisis escalated and the government announced an official lockdown in late March, the vast majority of our team have been working from home, and we were well prepared for this situation.

If I were to point to two critical areas that have enabled effective working in such a physically remote environment, it would be teamwork and good communication. The team has excelled on this front, and we have all been well supported by a robust technology platform that Dave Cooke and his team have adapted and evolved as the work from home setting has become "bau". Our plans for an eventual return to the office are already well advanced, taking direction from the official government and regulatory advice. I hope that when I write to you next I will be able to tell you about a successful return to the office!

ANZ's financial performance has not been immune to the crisis, and we've seen a substantial reduction in profitability that is reflected in our half year 2020 result, with statutory profit down 51% year on year. This



decline was driven primarily by credit impairment charges of A\$1.674 billion that included increased credit reserves for COVID-19 impacts of A\$1.031 billion. Furthermore, the valuation of investments in Asian associates was impaired by A\$815 million, largely due to the impact the virus is having in those markets. The ongoing uncertainty also resulted in the Board deferring its decision on the interim dividend until there is greater clarity regarding the economic impact of COVID-19.

The Group share price is 27% below 2020 highs, and our group CEO Shayne Elliott acknowledged that

ANZ's share price fall has caused our shareholders significant pain.

Our customers are experiencing unprecedented stress – many are devastated, with their jobs and income at risk, and the knock to peoples' wellbeing cannot be underestimated.

Closer to home, the business in Europe has performed strongly, contributing to Institutional Division's 10% increase in overall revenue, and adding value across the network and in our home markets. Europe continues to be a key part of ANZ's strategy.

A bit about me. I am originally from Scotland and have been "offshore" since the early 1990s. Prior to joining the team in Europe, I was based in Hong Kong leading ANZ's Loans & Specialised Finance business for all markets outside Australia and New Zealand. That followed 10 years in Asia with KPMG advising corporates, FIs and governments on fund raising, and RBS running the Asian Corporate Debt Capital markets team. This followed 11 years with ABN AMRO in London and a range of roles in natural resources, balance sheet management and syndication.

I'm really excited to have the opportunity to lead the team in Europe. The business is performing strongly and I am looking forward to working with the team to develop and grow the franchise.

I'll sign off by echoing Shayne Elliott: ANZ came into this crisis in good shape - financially, operationally and culturally, and we have a lot to be proud of. In Europe we have a strong client base and an experienced and mature team, both great ingredients to ensure we will emerge from the COVID-19 crisis in good shape.

I should make special mention of John Cruickshank who is the oldest surviving holder of the Victoria Cross. There is no doubt that the present Coronavirus crisis is having a profound impact on the world economy and international markets. Consequently, many Pensioners have been asking about the status of our own Pension Scheme.

As we go to press, the Trustee and the Scheme's Auditors are working towards signing off the report and financial statements for 31 December 2019. The Chairman's statement in the formal Trustee Report will also cover the current position re COVID-19 and this statement will be included in the usual Trustee Annual Newsletter which will be sent out later in the Summer.

Pensioners may also have seen the following statement in the notes field of their April pay advice:

The Trustee can assure you that the Scheme's funding position remains strong and there will be no change or disruption to your pension payments. Please call ANZ Pensions with any queries.

We have been asked to stress that if members do have any queries, they should contact the ANZ Pensions Team preferably by phone or email using the details above. However, any post sent to 40 Bank Street is being forwarded to the Team to deal with at regular intervals, although response times will be slightly extended because of this extra step. Please also be aware that for security reasons the Pensions Team still require any instructions to change where your pension is paid to be made in writing.

# John Cruickshank - 100 years old

Congratulations to John Cruickshank who celebrated his birthday on 20 May at his home in Aberdeen.



John is a well-known member of our Association not only following a successful career with the former Grindlays Bank and its former corporate entities, but also because of his distinguished service record with the RAF during the second world war.

Born in Aberdeen in 1920, John started work with the Commercial Bank of Scotland in 1938. At the outbreak of war, he was called for service with the Royal Artillery, but in early 1941 he applied for a transfer to the RAF. After spending time in Canada and the USA, he was awarded his pilot wings in July 1942 and returned to England. In 1943, he joined 210 squadron as a pilot on Catalina flying boats (see image) based in Scotland.

By mid-1944, John was an accomplished and experienced Flight

Lieutenant and on 17 July took off with his 10-man crew on a mission that was to earn him the Victoria Cross. Their task was to provide cover for the British Home Fleet against submarine attack in the Norwegian sea. During the mission they encountered a U-boat on the surface which they sank after their second pass. However, they encountered heavy anti-aircraft fire during the attack on the U-boat, killing their navigator and injuring four others, including John who sustained 72 shrapnel wounds, including pierced lungs and significant blood loss from several wounds to his lower limbs.

The following is an extract from the final part of his Citation. Quote: "By pressing home the second attack (on the U-boat) in his gravely wounded condition and continuing his exertions on the return journey with his strength failing all the time, he seriously prejudiced his chance of survival even if the aircraft safely reached its base. Throughout, he set an example of determination, fortitude and devotion to duty in keeping with the highest traditions of the Service."

John is the RAF's last living recipient of the Victoria Cross. He has been a long-standing member of the RAF Association and is currently President of the Aberdeen Branch.

John left the RAF in 1946 to resume his banking career with the Commercial Bank of Scotland and then Grindlays Bank until he retired in 1976. His career is neatly summarised in the following extract from the Grindlays House Magazine (Minerva) in April 1976. Quote: John Cruickshank V.C. retires from the Bank at the end of March after a very successful career, during which he earned the admiration and respect of all members of the staff. First posted overseas to India in November 1952 he saw service in Aden, Somalia, India, Nigeria and Sri Lanka where he had been General Manager since 1974. All of us who knew John were proud to have been associated with him and the citation he received during the war will always have a distinctive place in the Bank's history. Unquote

#### Jean Kelman - 100 Years Old

Congratulations to Jean Kelman who celebrated her 100th birthday on the 13 April. Jean's late husband, Steve, was originally employed by the National Bank of India.

Jean is in good health despite breaking her leg a week before her birthday which required an operation and 5 days stay in hospital. Unfortunately this meant that Jean had to spend her birthday in self-isolation at the care home in Somerset where she now lives. The Coronavirus lockdown measures have also meant that she has been unable to celebrate her birthday with any family members but they are looking to rectify this when the lockdown measures are eased.

Until a few years ago, Jean was a regular attendee of the local area annual lunch organised by area RLO, Keith Blackie..



# **OBITUARIES**

*Alan St Jean (17 November 1941 - 2 March 2020)* With thanks to Des Shady for the following tribute:



I first met Alan when I was transferred to 71 Cornhill, London in November 1969, to train as a foreign exchange dealer. My sitting position on the dealing desk was on his left, with Mike Tong on his right and Charles Comport sitting opposite me. Jimmy Warwick, Manager Money was downstairs. Unfortunately, none of these people are with us any longer.

Alan was the "Cable" (Pound vs US Dollar) dealer at the time and because of his French heritage, lots of French banks called him for prices. He allowed me (school French) to answer some of these calls, but once a price was hit he would grab the phone to make sure we weren't selling when we were actually buying. In addition to currencies, Alan was also proficient in making prices in various off market products such as the number of world cup goals etc.

Alan didn't have the taste for the English bitters and I found them just OK, so when we got the opportunity we would adjourn to "The Jampot" which sold *cold* Becks beer.

Alan was a great person to work with and an excellent trainer. I was privileged to visit banks in Singapore, Malaysia and Hong Kong with him in the early 1970's. He was highly regarded by the dealing community throughout the world.

#### (C) ANNUAL REPORT of the Committee for the year 2019

As required by our Constitution, the Association's primary objective is to encourage contact and communication between and to encourage social activities for its members. This year has been another very active and successful one for the Association. This success has been largely due to our team of Regional Liaison Officers (RLOs), on whom we depend to keep us in close touch with our members. Some of them, where they consider it appropriate, also organise social events in their Areas with RLOs of adjoining areas. Lunches were arranged by RLOs in Harare, Scotland, London, Mid and West Sussex, Orpington and Hayes and Kent Area and were all well attended and enjoyed by members and their partners. We have Regional Liaison Officers around the country and there are currently vacancies in 13 areas, including 5 in

East Anglia, 4 in the South, and 4 around London.

The Association's Annual Reception was held at the ANZ's offices in Canary Wharf and was well attended by over 65 members and guests. This was the first time that this event has been held in the ANZ offices for several years and we were grateful to our Patron and ANZ's CEO UK & Europe, Diana Brightmore-Armour, for offering us the use of their facilities and caterers for this function and the consequential cost savings that it enabled. Unfortunately, Diana was unavailable to address our members at the Reception and ANZ's UK Chief Risk Officer, Nigel Denby, attended in her absence and gave an update on the ANZ Group's business and cultural development both in Europe and worldwide. He also answered questions from members.

I was pleased to be re-elected as the Chairman. This meant for the year under review the Committee consisted of Peter Smith (Chairman), Neil Jones (Deputy Chairman), Sue Waters (Secretary), Mike Turner (Treasurer) and Committee members, Mary Lipscombe, Ann Twinn, Tony Twohey, Andy Woska, Jeanette Nunn and Denise Murphy with David Phibbs as Honorary Auditor.

At the beginning of 2019, the Association office was manned every first and third Friday of the month. During 2018, we implemented new database and office systems as part of our project to comply with the new Data Protection laws (GDPR) and to remove our previous dependence on the use of ANZ's own technology systems and networks. As a consequence, we have become less reliant on paper and hence attendance at the ANZ office in order to deal with the Association's administration functions. By the end of 2019, we no longer routinely attend the office but do so only on an as needed basis. Sue Waters as Secretary has handled all the Association's correspondence. Mike Turner pays the bills and keeps the accounts up to date as well as organising the Annual Reception and the Annual General Meeting. Jeanette Nunn has done a great job of keeping the database up-to-date, especially following the new Data Protection legislation and the associated implementation of a new database system.

Mary Lipscombe has done a wonderful job as Editor of the Newsletter. The three editions which were issued during the year have been popular and well received by our members. Tony Twohey has also played a pivotal role in the publication and printing of the Newsletter and the associated internet-based technologies for both our Newsletter and website. We are actively looking for successors to this role which Tony has undertaken for several years.

The MINERVA CLUB continued to meet at the Mug House Wine Bar in Tooley Street and which attracted over 50 people during 2019. The Club met at the Mug House in March, and June. Unfortunately the November meeting had to be cancelled on account of the London Bridge terrorist incident which occurred only minutes before the scheduled meeting time. Photos from some of these meetings can be found in the gallery on our website.

We are grateful to the Bank in London for their support during the year and especially Mary Bacon and her staff in the Pensions Department. We are also grateful to the Bank Support Services for the use of an office and associated materials and equipment.

As at 31st December 2019, our membership was 1,256 which was 2 less than as at the beginning of the year. Our thoughts and sympathy go out to the families and friends of the 40 of our members who died during 2019
