#### Tribute to Denis Armstrong (1944 - 2016)



Denis joined William Brandts Bank in 1960's in their merchant Banking office at 36 Fenchurch Street. William Brandts subsequently became part of the Grindlays Bank Group. Throughout his career, Denis is remembered as much for being an inspiration and popular person as he was a successful career Banker. Before joining Brandts he worked for a short period with a shipping company. In Brandts Denis worked in the Export Finance division and became a Director. During this period, the Brandts business became a part of the Citibank and then Grindlays Banking Group where his career continued to develop rapidly. At the same time, he and his colleagues used to socialise regularly at the "Wine Bar" in Fenchurch Street.

He was part of the Grindlays executive team at the time of the acquisition by ANZ and was a key member of the team established to amalgamate the two businesses in London and across the world. In the late 80's, he was appointed Head of Correspondent Banking in London. His team remember him for being fun to work with. They

were expected to play hard and work hard. His team loved and respected him and would do anything for him. The "after work" team building sessions were an important component of his management style!

In 1991 he was posted to Karachi as General Manager, Pakistan. During the 3 years Denis was in Pakistan, the bank enjoyed unprecedented growth. His management and team building style encouraged initiative encouraged the development of many younger staff members to express themselves and grow their careers.

Denis's parties at the bank house in Karachi were legendary. During his time in Pakistan he brought in a quasi-5-day week for local staff and encouraged the development of bank sponsored social facilities and activities for all local staff irrespective of rank.

Denis would also ensure that the expatriate staff in Pakistan were well looked after. They used to joke about the 'Armstrong Starter Pack' that he would give to all new expatriates. Ostensibly this was made up of a few essentials to help settle them into life in Pakistan, but of course, being established by Denis, it mainly consisted of a few bottles to remind them of home.

Denis became Chairman of the Board of Governors of the British Overseas School and a leading light of the British Businessmen's Association in Karachi. In 1995, he was posted to Melbourne taking up a role in the International Banking Division to help widen the knowledge of the ANZ Group's overseas operations in Australia. In 1996, he organised an International Country Managers meeting in Melbourne and of course no expense was spared in ensuring all in-coming visitors to Melbourne, from the far reaches of the ANZ network were treated like royalty (see photo p2).

Denis returned to the UK in 1997 and retired from ANZ. He subsequently joined the Pensioners Association committee and was Chairman from 2006 until 2014 when he was first diagnosed with cancer. His time in charge of the Pensioners Association oversaw several changes

## Message from Diana Brightmore-Armour, CEO UK, Europe and Middle East



As I begin to write this piece for the members of our Pensioners Association, it feels like the winds of change are blowing hard. Since my last note to you, the UK electorate voted to 'Brexit', we have a new US President and ANZ has reshaped its

business significantly – all factors that have influenced our results for the 2016 financial year.

The Group released its results on 3 November with the headline that our cash profit of A\$5.9billion was down 18% vs. FY2015. While it has been a year of transition for ANZ, with the Group taking a number of difficult decisions to address headwinds and put the Bank on a path towards improved performance in future years, the result reflects a good performance in ANZ's core domestic franchises.

Our team in Australia and New Zealand delivered strong performances in the Retail and Commercial businesses particularly in home and small business lending. And there was a lot of buzz when we launched Apple Pay and Android Pay in Australia and Apple Pay in New Zealand. In Institutional we saw improved returns and we maintained our number one ranking for customer relationship management in every market.

The result also reflects an emphasis on delivering strong capital and cost management outcomes together with A\$1,077million of charges (after tax) for Specified Items mainly related to the way we account for restructuring, technology and productivity initiatives.

There has been significant reshaping of the business, driven by ANZ's strategic focus to create a simpler, better capitalised and more balanced bank that produces better outcomes for customers and shareholders. Specifically, in terms of the specific decisions taken to refocus ANZ's resources – capital, technology and people – we sold the Esanda dealer finance portfolio, as well as announcing the sale of our Retail and Wealth businesses in five Asian markets. Adjusted Pro-Forma Cash Profit was \$7.0 billion, down 3%, while Profit before Provisions increased 6% as the benefits of simplification and rebalancing initiatives began to emerge. Return on equity was stable in the second half of the financial year at 12.2% (adjusted Pro-forma Cash Profit basis).

The Final Dividend of 80 cents per share is consistent with guidance provided at the Interim Profit announcement. The Total Dividend for FY16 is 160 cents per share fully

franked down 12%. (see Summary below)

As I reflect on the year, I'm pleased that we have made so much progress in reshaping and simplifying our business. We are very well positioned as we head into a new 12 month cycle, having delivered significant Risk Weighted Asset reductions that are already positively impacting our net margins. Internally, we are confident we have the right structure and teams in place to meet the demands of our high value clients, focusing increasingly on attractive areas where we can carve out a winning position. I'll leave you with the comments of Shayne Elliott, Group CEO, reflecting on the next phase of our journey:

"We now we have the organisation aligned and we have established momentum in relation to the work that still needs to be done. This sets us up well to increase the pace

of execution in 2017 and to deliver a better bank for customers and for shareholders."

#### **Obituaries**

#### Chris Norton



Chris was recruited to ANZ's Cornhill office in 1968 by Dick Milnthorpe, where he worked as a software code writer in a team headed by Sid Ings and including Eamon Veaney and the late Trevor quickly Hinds. Chris demonstrated a flare for software development and innovative systems design. He was involved in many of the financial industry developments that applied to the whole City. With

Bruce Plaice-Leary as a director of SWIFT UK, ANZ represented all overseas banks in London in the development of SWIFT, the original international payments system which became the universal standard system for payments across the globe, and continues to this day. Chris, as ANZ's working party member, was key to the development of SWIFT and in 1977 ANZ was one of the initial 25 banks to implement the system. Chris provided the design to enable us to integrate the UK based CHAPS and SWIFT payment systems giving the bank significant competitive advantage in the payments business. Chris was enormously respected amongst his peers in other banks. His work on SWIFT was a matter of rare pride for him and he was delighted to recently contribute to the research carried

out by the LSE for a book on this example of worldwide cooperation.

Chris, together with the late John Gilbert were the leading lights in supporting the evolution of ANZ's main systems hardware from the 70's until he left ANZ in the late 90's. He provided technical support to ANZ's worldwide network of Midanz operating branches. Chris was instrumental in creating a PC version of Midanz which he installed in India. After the acquisition of Grindlays, he became Head of Software for the ANZ Grindlays London based operations and in 1991 became the Manager of the ANZ Group's London IT operation.

In 1998, he re-joined Bruce Plaice-Leary in a consultancy business where his knowledge of payment systems and, by then, the emergence of the internet was to prove invaluable. Chris was a social animal and his circle of friends was extensive. He was outgoing and generous, sometimes contemplative but always ready to talk, always happy to help. Chris's favourite pastime was long distance walking such as the Pennine Way. He also loved sailing, especially in the Aegean and had a Yachtsman's certificate. His homemade beer was exceptional. In his retirement, he devoted much of his time to his allotments. Chris died of cancer on 26 August 2016, aged 68, and leaves a widow, Sue, three sons and four grandchildren.
